Program Highlights

Children's Medical Center Dallas is a 490-bed, free-standing pediatric hospital nationally ranked in all 10 pediatric specialties. Pharmacists attend patient care rounds daily as an integral part of the team in hematology/oncology, general pediatrics, acute care services, solid organ transplant, anticoagulation and infectious diseases. In the Emergency Department, clinical pharmacists provide 24-hour comprehensive clinical coverage including code response. Critical care pharmacists are embedded in nine separate rounding teams caring for high acuity patients in the PICU, Level I Trauma Center, Level IV NICU and dedicated Cardiac ICU. As a teaching hospital associated with UT Southwestern, Children's Medical Center Dallas is a rich environment for learning which promotes strong interdisciplinary collaboration. Residency program highlights include a formal mentorship program, wellness committee, 40+ pharmacy residency preceptors, PGY2 early commitment, longitudinal medical emergency rotation, and the ability to customize the program with a wide variety of elective rotations. 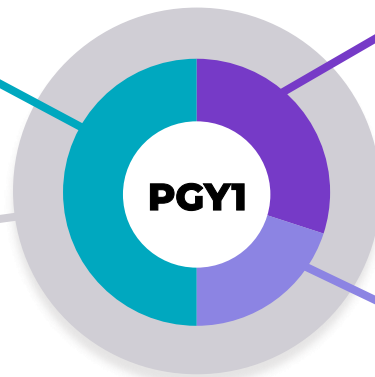
Rotation Structure
